### **ANNUAL REPORT 2002**

The Committee has pleasure in presenting its annual report for the year ended 30 November 2002.

### 2002 AGM & Annual Dinner

The Annual General Meeting of the Association was held at The Queen's Club on 24<sup>th</sup> April 2002. Messrs Jackson, Tatum & Rusling were re-elected as President, Hon. Secretary & Hon. Treasurer respectively. The position of Hon. Auditor became vacant following the retirement of Mr. Howorth, & authority was granted to the President & Chairman to appoint a successor for 2002. The Committee would like to place on record its sincere thanks to Mr. Howorth for the significant contribution he has made to the running of the Association over more than 25 years.

Messrs Brown, Cooper, Cummings, Pool, Seddon & Weatherill were all re-elected to the Committee. Mr. Spink was elected to the Committee for the first time, replacing Mr. Macintosh. At the meeting of the Committee which immediately followed the AGM, Mr Boden was elected as the new Chairman of the Committee.

The Committee's Report and Accounts of the Association for the year ended 30 November 2001 were presented at the AGM and unanimously adopted.

The AGM was followed by the annual dinner which was also held at The Queen's Club. As usual the dinner was a highly enjoyable occasion. Members and guests were entertained by an excellent speech (& an especially written "Pubs" song!) from fellow member, Mr. Robert Dolman, Chairman of the Jesters Club and Senior Partner at Wedlake Bell Solicitors.

### **Match Results**

The 2002 Season got off to a winning start with a narrow victory over the Fitzwilliam Club to regain the Courtney Salver, where the Pubs team, led by Conor Boden, translated their seemingly unassailable  $4\frac{1}{2} - \frac{1}{2}$  overnight lead, into a nail-biting 5-4 victory, (this year the Pubs team will be in Dublin on  $29^{th}$  &  $30^{th}$  March in their bid to retain the salver. Make sure to catch them "fresh" from the experience at the Annual Dinner on  $1^{st}$  April!).

Including the Fitzwilliam victory, the Association notched up 12 wins in total, including ones against Bristol University, Ealing LTC, Oxford Penguins & King's College School. Whilst amongst our 3 losses (the lowest number for a good many years) was a narrow, final round 5-4 defeat to the All England Lawn Tennis & Croquet Club.

For the second year, four mid-week matches were played against schools, with victories achieved against UCS, Harrow & Magdalen College School, and a defeat at the hands of Eton. Thanks go again to Nigel Spink for his hard work in organising both fixtures and teams. Anyone keen to be involved in these matches should contact Nigel as early as possible to avoid disappointment.

### D'Abernon Cup

As a result of the amount of walkovers in the 2001competition and feedback from Team Captains, in 2002 we trialled a new round robin format for the first round of the D'Abernon Cup, grouping teams into two pools with all matches in each pool held at an indoor venue on a set day. The pool winners and runners-up then joined the previous year's competing semi-finalists in the quarter-final draw. In the semi-finals, KCS beat Lancing Old Boys, and the Old Paulines received a walkover against the Old Carthusians. The final was then played at the All England Club on courts 3,4 & 5 in glorious sunshine and was not only an exact rematch of the 2001 final, but also finished with the same score, the Old Paulines beating the KCS Old Boys 5-4.

Following feedback from team captains we will be continuing with this format for the 2003 competition.
