ANNUAL REPORT 2008

The Committee has pleasure in presenting its annual report for the year ended 30 November 2008.

2008 AGM & Annual Dinner

The Annual General Meeting of the Association was held at The Queen's Club on 29th April 2008. Messrs Jackson, Tatum & Rusling were re-elected as President, Hon. Secretary & Hon. Treasurer respectively. Mrs B. Gabriel was re-elected as Hon. Auditor.

Messrs Brown, Cooper, Seddon, Siviter, Weatherill and Yuill were all re-elected to the Committee. At the meeting of the Committee, immediately following the AGM, Mr Boden was elected as the Chairman of the Committee for the sixth year. The Committee's Report and the Accounts of the Association for the year ended 30 November 2007 were presented at the AGM and unanimously adopted.

The AGM was followed by the annual dinner, which was also held at The Queen's Club. Our guest speaker was Mr. Charlie Wijeratna, the Commercial Negotiations Director for the London Organising Committee for the Olympic Games & Paralympic Games in 2012. Members were treated to a most interesting update both on how the Olympics were won for London and most importantly what progress is being made in preparation for 2012.

Match Results - Jonathan Cooper (Hon. Match Secretary) writes:

The 2008 season completed despite the showering of rain last summer and I am very pleased to report it was a successful one. 23 matches played of which 15 were wins, 3 draws and only 5 losses. And the stat for this year is that the number of wins obtained was the highest recorded for a season.

Another notable match in the year was to celebrate the centenary of Stoke Park Club, which saw Stoke Park Club pit its wits against a combined team of the PSOBLTA, All England and International Club. A thoroughly enjoyable day was had in the impressive surroundings of Stoke Park and despite Lee Childs representing Stoke

Park Club; the combined team gained a victory. Our thanks go to the King family for their continuous support of the PSOBLTA.

Many thanks to all 32 players who represented the Pubs in the season and once again a special mention should be made to Brad Keenes, who was once again the most capped player with 16 appearances. Will there be a new contender for his title in 2009...?
